## **Disclosures of Your Personal Data**

### **External Parties**

#### Where Your Personal Information Is Held

# **How Long Your Personal Information Will Be Kept**

We will keep your personal information while you have an active matter with us, when we believe you may be interested in our services, or when we are providing services to you. We will keep your personal information, as a minimum, for as long as necessary:

- To respond to any questions, complaints, or claims made by you or on your behalf.
- To show that we treated you fairly.
- To keep records required by law.

#### **International Transfers**

- Ask that personal data we hold about you is given to you, or where technically feasible, a third party chosen by you, in a commonly used, machine-readable format.

The rights listed above may apply in certain circumstances, and so we may not always be able to comply with your request to exercise these rights. We will usually respond to a request from you to exercise your rights within 1 month of receipt, but it might take longer if your request is particularly complex or if you have made a number of requests. Please be aware that we may need to process your personal data and/or request specific information from you to help us comply with your request. You will not usually have to pay a fee to exercise these rights, but we reserve the right to do so if your request is clearly unfounded, repetitive, or excessive, alternatively, we may refuse to comply with your request.

### **How to Complain**

We hope that we can resolve any query or concern you may raise about our use of your information.

The General Data Protection Regulation also gives you right to lodge a complaint with a supervisory authority, in particular in the European Union (or European Economic Area) state where you work, normally live or where any alleged infringement of data protection laws occurred.
